<b>Regulations (Conditions of Play)</b>	This tournament will be run in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes, General Competition Regulations (GCR) and Badminton Europe U17 Circuit Regulations. In the event of any dispute, the decision of the Tournament Referee will be final. This tournament will strictly enforce the Clothing, Equipment, and Advertising Regulations as outlined in the BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16.
<b>Scoring System</b>	Best of three games to 21 points, as per the Laws of Badminton (BWF Statute 4.1)

<b>Presentation Ceremonies</b>	All prize ceremonies will take place on Sunday, <b>13 July 2025</b> immediately after the conclusion of each final. Medals/trophies/other will be presented to all champions and finalists. No equipment, including rackets and is allowed to be brought onto the podium. Clothing worn during the ceremony must be in accordance with the BWF GCR.
<b>Medical Services</b>	A medical officer will be available free of charge at the venue during tournament hours.
<b>Doping</b>	Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples. Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE). To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match. Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).
